# How to Conduct Driver Safety Training, Without Impacting Billable Hours

I 'm willing to bet you'd love a way to have your drivers trained and evaluated without taking them off delivery routes or wasting billable hours this Winter. Driver ride-along inspections are a cost-effective method to evaluate your delivery staff without detracting from productivity. This offers a safety expert a real-life snapshot of your company's delivery procedure to evaluate and report on.

### **Inspection Benefits**

There are many benefits to a driver ride-along inspection, where a propane safety expert accompanies drivers on delivery routes.

#### Prevent expensive accidents.

Ride-along evaluations with a safety expert will help promote a culture of safety in your company and minimize the risk of equipment damage and personal injury costs. Any mistakes can be corrected then and there, offering an instant feedback loop that will resonate with the driver.

#### Evaluate performance when it matters most.

It can be easy for seasonal drivers to forget information over the Summer, so waiting until Spring is

## **Fine-Tuning Training Needs**

As a professional trainer, here are some of the most common issues I correct during driver ride-along inspections:

# Lack of familiarization with equipment used on a day-to-day basis.

Many drivers don't fully understand all the functionalities of their truck. They should be familiar with bobtail inspections, safety devices, meter creep tests and other important features designed to keep them safe.

# Improper use of personal protective equipment (PPE).

Frequently, I see deliveries where the driver forgets or chooses not to wear their safety glasses. I have also seen them not wear gloves, or wear the wrong type of gloves while handling propane.

# Bobtail placement at customer locations.

When, where and how we put a truck in a customer's yard has a big impact on both

safety and satisfaction. Hazards including obstacles and inclement weather can determine how best to place the bobtail.

The top providers of driver ride-along inspections even perform inspections of customer locations and educate drivers on National Fire Protection Association (NFPA) 58 code compliancy, then provide a report to your management team that covers any code deficiencies that exist at those customer locations.

### **Frequently Asked Questions**

# **Q:** Why should I bother with driver safety evaluations? I think my team has it under control.

A: Having confidence in your employees is great, but accidents can happen. A bobtail accident is an extremely dangerous scenario that can put your driver and company at risk. All it takes is one severe accident to shut down your whole operation.

### Q: How will it help my drivers?

A: Ride-along driver safety evaluations are designed to help delivery drivers be the best they can be. They give each driver the opportunity to work directly with a trainer so that they can get feedback that applies to their skills.

### Q: How will it help my managers?

A: Driver safety evaluations show your management team how your delivery team operates in the field. Based on the trainer's feedback, they can assess where each driver is excelling and where there is room for improvement.

# **Q:** How often do I have to schedule driver ride-along inspections?

A: Industry best practice recommends a three-year refresher for all delivery drivers. Trying to stick to a budget? Schedule full or half days for your newest drivers, then expand to more experienced drivers. Everyone has to start somewhere and something is always better than nothing.
